You will find the Minutes of the 470<sup>th</sup> Stated Meeting of the Presbytery of Des Moines held on November 13, 2007, at the First Presbyterian Church of Ottumwa, following this letter. Most members are receiving the minutes by going online to download them from our Presbytery web site. Only those without Internet access receive printed copies.

Please read through these minutes to both remind yourself of what occurred and to check them for accuracy. Please send any corrections to me, preferably in writing. This includes use of e-mail.

We elected new officers and members of committees and other Presbytery entities, as well as Commissioners to the General Assembly and Synod. Elder Ray Peters, a member of the Ankeny Presbyterian Church, is our new moderator. We approved the 2008 budget for the Presbytery. We had a very meaningful 'laying-on-of-hands' for Sara Hopkins, an elder in the First Presbyterian Church in Newton, as she was Commissioned as a Lay Pastor. We had conversation about caring for pastors. The Rev. Ann Rouse (Monroe) guided us in a Bible study focused on "Crossing the River." We approved some new and continuing pastoral relationships. The meeting concluded with a special time of worship that included youth bell and choral choirs from the host church. These are just some of the highlights.

The Presbytery VOTED to approve the consent agenda and all the items on it.

**SEATING OF CORRESPONDING MEMBERS**

The Presbytery VOTED to seat the Rev. Elizabeth Knott, a member of the Presbytery of Seattle, as a corresponding member for this meeting.

**INTRODUCTION OF FIRST TIMERS AND GUESTS**

**APPOINTMENT OF PARLIAMENTARIAN**

Moderator Kate Stangl reminded the Presbytery that the Rev. Ken Rummer, pastor of the First Presbyterian Church of Corning, was appointed as the parliamentarian for the remainder of 2007.

**APPOINTMENT OF RECORDING CLERK**

Stated Clerk Phil Barrett reported that Elder Becky Diebold, a member of the First Presbyterian Church of Ottumwa, had been appointed as recording clerk for this meeting.

**WELCOME BY HOST CHURCH**

The Rev. Sue Babovec, pastor of the First Presbyterian Church of Ottumwa, welcomed the Presbytery.

**APPROVAL OF AUGUST STATED MEETING MINUTES**

The Presbytery VOTED to approve the minutes of the 469<sup>th</sup> Stated Meeting held on August 18, 2007, as printed and distributed.

**REPORT OF THE STATED CLERK**

I-I-15 Stated Clerk Phil Barrett reported that all reports had been filed with the Synod of Lakes and Prairies or the General Assembly as of this date, and all correspondence received on behalf of the Presbytery has been assigned, referred answered.

I-I-16 We still welcome invitations to host the following stated meetings of the Presbytery in 2008:

Tuesday, May 20  
Saturday, August 16

The Saturday, January 19 Presbytery Meeting will be held at the Ankeny Presbyterian Church, and the Tuesday, November 11 Presbytery Meeting will be held at the St. Paul Presbyterian Church in Johnston.

I-I-17 The Community United Presbyterian Church of Hartford has notified the Presbytery that it has elected former pastor, the Rev. George Mason, as Pastor Emeritus.

I-I-18 The Moderator has appointed a five-member Investigating Committee to deal with the accusation of an offense against a member of the Presbytery. The committee is made up of one female clergy, one male clergy, one male elder and two female elders. This committee, along with the Permanent Judicial Commission of the Presbytery, were trained and oriented regarding their work on November 3 by the Rev. Mark Tammen, Director of Constitutional Services of the Presbyterian Church (U.S.A.).

I-I-19 Elder Ron Haag (Des Moines, Douglas Avenue) has resigned from the Permanent Judicial Commission of the Presbytery, Class of 2008, for health reasons. This vacancy has been referred to the Nominating Committee.

The following recommendations from the Stated Clerk were adopted by the Presbytery:

I-R-6 I have received reports from the commissions to ordain and/or install the Revs. David Braak (Ankeny), Nathan Lamb (Hartford, Community United) and D. Scott Vandenheuvel (Creston, First). I recommend that these commissions be dismissed with our thanks.

I-R-7 The Annual Review of Session Records was held on October 4, 16, 25 and 30. Our clerks of session continue to do a great job, whether they are new to the position or have been serving for some time. Each year, more session moderators attend the review sessions, both learning some things and adding important support to the work of the clerks.

I recommend that the session records of the following congregations be approved without exception:

Adair-First; Audubon-First; Brooklyn-First; Carlisle-Scotch Ridge; Creston-First; Clive-Heartland; Corning-First; Dallas Center-First; Des Moines-Central, -First, -Highland Park, -Knox United, -Park Avenue, -Union Park and -Westminster; Dexter-First; Ewart-First; Gibson-First; Greenfield-First; Grimes-First; Grinnell-First; Guthrie Center-First; Hartford-Community; Indianola-Trinity United; Johnston-St. Paul; Knoxville-First; Leon-First; Lucas-First; Montezuma-First; Oskaloosa-First; Ottumwa-East End; Perry-First; Sharpsburg; Tingley; White Oak; Winterset-First.

I-R-8 I recommend that the session records of the following congregations to be approved with exceptions;

Allerton-United; Ankeny; Atlantic-First; Bedford-United Christian; Centerville-First; Des Moines-Cottage Grove Avenue, -Douglas Avenue, -Fort Des Moines; Diagonal-United; Earlham-First; LeRoy-First; Malcom; Newton-United; Ottumwa-Westminster; Platte Center; West Des Moines-Covenant; Windsor Heights-Windsor.

I-I-20 The following churches have not submitted their session records and have not made arrangements for their review:

Monroe; Mt. Ayr-Baptist Presbyterian; Ottumwa-First; and New Sharon-First (which has not submitted records for over six years).

### **CROSS MINISTRIES ACTIVITIES**

Elder Roberta Victor, Ph.D., executive director of CROSS Ministries, highlighted three activities being provided by CROSS Ministries.

### **PROFESSIONAL CARE AND DEVELOPMENT COMMITTEE**

Committee Moderator, the Rev. Ken Rummer, and Committee member, Rev. Jim Wallace, presented a skit on encouraging pastors (or not). An article was then distributed regarding why pastors leave. Jim Wallace highlighted four focus items from the article – how well pastors are cared for, how conflict is managed in congregations, collegiality among pastors, and skills of pastors versus expectations of congregations. The Presbytery gathered in small groups to share ideas for caring for pastors then some of the thoughts from the groups were shared with the whole body. The Rev. Sara Speer Palmer, a member of the committee, shared unique issues facing female clergy.

The Presbytery VOTED to approve the following action of the committee:

B-A-13 Gave permission to the Rev. Claude Jones (at large) to labor outside the bounds of the Presbytery as the Director of Church Relations for the University of Dubuque Theological Seminary. The committee determined this to be a validated ministry under the terms of the Presbytery's policy and Rev. Jones will be retained on the Active Member list of the Presbytery (G-11.0406).

The Presbytery VOTED to adopt the following recommendations from the committee:

B-R-10 That the Rev. Shamaine Chambers King (Windsor Heights, Windsor) be granted permission to labor outside the bounds of the presbytery to officiate at a wedding in Carmel, California, on October 10, 2007.

B-R-11 That the Rev. George Salnave (Montezuma, First) be granted permission to labor outside the bounds of the presbytery to officiate at a funeral in Marshalltown, IA, on October 26, 2007, for one of his church members.

B-R-12 That the Rev. Don Freeman (Newton, United) be granted permission to labor outside the bounds of the presbytery to officiate at a wedding in Dubuque, Iowa, on November 10, 2007.

- B-R-13 That the terms of call for the Rev. George Salnave (Montezuma, First) be approved without change for 2007.
- B-R-14 That the Rev. Pat Summers (at large) be granted the status of Honorably retired as of October 1, 2007.

A service of worship honoring Pat's retirement was then held.

Ken highlighted a survey the committee was asking folks to fill out as well as some items of information from our denomination's Board of Pensions.

### **STEWARDSHIP AND MISSION INTERPRETATION COMMITTEE**

Committee Moderator the Rev. Dale O'Connell presented the report.

Dale highlighted the visit of Jonna Reeder to our Presbytery in October and her encouragement to get the funds raised to send Denise England to Egypt as a mission worker. Jonna also encouraged churches to recruit young adults to serve as volunteers in mission in other parts of the world.

Dale then highlighted upcoming offerings and events sponsored by the Committee, he informed the Presbytery that the 2008 focus for the Committee will be stewardship training. Committee member Rev. David Ewing provided a helpful presentation regarding the upcoming Christmas Joy Offering.

### **BUDGET AND FINANCE COMMITTEE**

Committee Moderator Elder Pat Aksamit presented the report.

The committee presents the following items as information:

- D-I-5 The Westminster Presbyterian Church of Ottumwa, Iowa, reported that a lift had been installed in the church building. Since no funds were borrowed for the project, only this report is necessary.
- D-I-6 Pat updated the Presbytery on the process of selling the former Clifton Heights property. A final action should be presented to the Presbytery in January.

The Presbytery VOTED to approve the following action of the committee:

- D-A-1 Granted permission to the Westminster Presbyterian Church of Ottumwa to sell its manse. The legal description of the property is as follows:

*128 Fairview Avenue, Ottumwa, Iowa  
Lot 7, Block 3 & Lot 8, Block 3 of Fairview Addition, Ottumwa, Iowa*

The floor was opened for other nominations. There being none, the Presbytery VOTED to close nominations and instruct the Clerk to cast an electing ballot.

C-R-9 Together with the Congregational Care and Development Committee, that Elder Sara Hopkins (Newton, First) be Commissioned as a Lay Pastor and be given full privileges of conducting the Sacraments, performing weddings, and under appropriate supervision, moderating session meetings.

Sara graduated from the Center-Learn program in June, 2007. The committee conducted a final interview with her on June 21, 2007. The committee heard her preach, reflected with her on her call to ministry, and examined her Statement of Faith. (This statement of faith appears as **Appendix C** at the end of these minutes.)

The Presbytery VOTED to adopt this recommendation. A Service of Commissioning was then held by the Presbytery which included a laying-on-of-hands.

**CONGREGATIONAL CARE AND DEVELOPMENT COMMITTEE**

Committee Moderator the Rev. Ann Rouse presented the report.

The Presbytery VOTED to approve the following actions of the Committee:

A-A-17 Approved the dissolution of the pastoral relationship between the Rev. Kirk Erwin and the First Presbyterian Church, Knoxville, Iowa, as of September 30, 2007.

A-A-18 Appointed the Rev. Linda O'Connell (Lucas, First) as Moderator of the session and congregation of the First Presbyterian Church, Knoxville, Iowa, as of October 1, 2007.

A-A-19 Appointed the Rev. David Endriss (Indianola, Trinity) as Moderator of the session and congregation of the First Presbyterian Church, Chariton, Iowa.

### **COORDINATING COUNCIL**

Council Moderator Elder Lila Jean Jensen presented the report.

The Presbytery VOTED to approve the following actions taken by the council;

- E-A-17 Reviewed the August 18, 2007, 469<sup>th</sup> Stated Meeting of the Presbytery.
- E-A-18 Planned the November 13, 2007, 470<sup>th</sup> Stated Meeting to include a time of Bible Study, election of officers and worship including the celebration of the Sacrament of the Lord's Supper.
- E-A-19 Made initial plans for the January 19, 2008, 471<sup>st</sup> Stated Meeting of the Presbytery to include a beginning of a year of celebrating 165 years of ministry by the Presbytery.
- E-A-20 Received a communication from the Congregational Care and Development Committee indicating concern for the Cottage Grove Avenue Presbyterian Church and its ministry with the Sudanese, and wondering about the current structure of the Congregational Care and Development (CCD) and Professional Care and Development (PCD) Committees dividing the work of a single Committee on Ministry (COM). Upon a motion from the floor, the Presbytery VOTED to grant permission for the Sacrament of the Lord's Supper to be served at the Presbytery Youth Event to be held at the Community United Presbyterian Church in Hartford, Iowa, on November 16-17.

## APPENDIX C

**Statement of Faith  
Sara Hopkins****November 2007**

**J – REPORT OF THE GENERAL PESBYTER****APPENDIX D****November 13, 2007**

We are part of a denomination that attempts to walk a carefully balanced path between honoring the voice of individuals and the voice of the body. We basically operate on a “will of the majority” basis, and at the same time have both a practice and process for individuals to express differences with the majority. At times, the will of a minority wins favor with the majority and changes the direction or action of the body. I believe this is one of our strengths and one we need to cultivate even more. This is not to say that we do it perfectly, or even well at times. We’re humans, we’re sinners, so we fall short. However, we must keep trying to make this and other strengths more useful and helpful.

Voices of other groups or individuals also impact our lives. Right now we are inundated with political voices, commercial voices, media voices, entertainment voices. We also hear relationship voices, intimate voices, job voices, educational voices, individual voices. Which voices do we listen and when? There are so many! We all feel this way at times, and in either frustration or fatigue, we revert to listening to our own voice, making it the authoritative one. Then what happens? We run into problems when my thought, my position, my experience become the ultimate truth for life. A person who thinks or believes differently from me is wrong, and I, only I, am right.

Our country, our culture, and yes, even our church is caught up in this in significant ways today. Individual desires and demands become the basis for what our church is supposed to be and do. Unfortunately this is not a new phenomenon. In the Gospel of John, the description of what happens after Jesus feeds the 5,000 is interesting. The Jewish leaders had been arguing about the meaning of every word of the Law, and now they pursue Jesus around a lake, peppering him with questions. The problem is they weren’t looking to learn something new. They wanted him to agree with their opinions, and nothing less would satisfy them. Jesus gives a response to their questions, and, as usual, it is not what they want to hear. It is confusing as he talks about eating flesh and drinking blood. It really wouldn’t have mattered how carefully he chose his words. To hear and understand a spiritual truth requires a spiritual heart. These folks were too full of what they thought was truth to allow their spirits to be fed. Today people hear sermons, presentations and other voices in their faith lives but their hearts and minds are already closed. To agree with their views is certainly of God, to disagree is heretical or apostate. I suspect God is pretty sad about those who hear only their own voice.

Unfortunately leaders of our Presbytery and I regularly are confronted with voices stating that their voice or process is the only way. It is hard to work with these folks because it feels like a waste of breath. We all have a variety of gifts and experiences that impact what we say and do. When added to a conversation or a situation, these are helpful, important, and even critical. When these attempt to control or demand in a situation, it is very hard for God’s voice to be injected. We don’t stop our work, and we try to allow for time to discern what God is doing here and what God wants in the situation. Sometimes this works. Other times the voice of impatience and demand for immediate action blocks out God, and yet, as only God can do, we are constantly surprised by God’s ability to overcome these barriers – in time.

As we work together to serve God, to help show the love of God in this time and place, whose voice are we listening to? How we answer will make all the difference in how well we are able to do God’s will.

Speaking of listening to God's voice, the time since our last meeting has been an exciting one as we have ordained, installed and put in place at least eight pastors.
