

# PULPIT SUPPLY LIST

Presbytery of Des Moines  
August 2010

A vital service of the Presbytery of Des Moines is to provide churches a list of supply preachers who lead worship for churches which have no pastor, or when a pastor is away. Pulpit supply is intended to be a Sunday-by-Sunday relationship. If a church intends to invite the same preacher for more than two consecutive weeks in a given month, Presbytery approval is required through the Congregational Care and Development (CCD) Committee. If this situation occurs because of an emergency or time constraints, the CCD must be informed.

The approved *Pulpit Supply List* of the Presbytery is for the uses of churches when seeking persons to fill pulpits in the absence of the pastor. Churches *without* installed or appointed pastors may only use persons from this list to fill pulpits. If there is a desire to use someone who is not on the list, permission from the CCD Committee is required. Churches *with* an installed or appointed pastor may use the list or may invite another person of their choosing with the permission of the pastor and/or session. The following persons have been approved by CCD as presbytery supply preachers:

## SPECIAL NOTE:

All churches are reminded that the fees below represent minimums and do not necessarily represent full and appropriate compensation for services rendered. When calling a person to act as a supply pastor, the caller should confirm the financial arrangements at that time.

The minimum fee for pulpit supply in churches of **less than** 200 members is \$75 for one service. \$25 extra for a repeat of the same service, plus 50 cents per mile (rate adjusted for 1/1/10). Yoked fields may split the total fee equally.

The minimum fee for pulpit supply in churches of **more than** 200 members is \$100 for one service, \$25 extra for each repeat of the same service, plus 50 cents per mile (rate adjusted for 1/1/10).
