Presbyterian Disaster Assistance Launches Humanitarian Aid Appeal for Middle East

(From the Presbyterian News Service) With Israeli and Hamas forces plunging deeper into violent conflict and the death toll in Gaza steadily mounting, Presbyterian Disaster Assistance has launched an appeal to help provide humanitarian relief

supplies to the stricken area. PDA is supporting relief efforts as a member of the Geneva-based Action by Churches Together (ACT) International alliance. These are initial efforts and will be expanded later as the situation further unfolds. The PDA-supported efforts have included provision of food – including high-energy biscuits for children - medicine and blankets, as well as the deployment of trauma counselors. Correction on "Affirmative Vote" Article

I just read the article on the Wider Circle-E version from January 22 about the vote on Amendment B that was taken at the January 17 Presbytery meeting. I beg to differ on the reference to the following section.

"The language, if approved by a majority of Presbyteries (87 out of 173) of the PC(USA) would mean that current G-6.0106b language would change from excluding persons who are homosexual from full inclusion and participating in the offices of our church, Deacon, Elder and Minister of the Word and Sacrament. While the General Assembly 2008 did rule that all Definitive Guidance and Authoritative Interpretations (From 1978 until the adding of G-6.0106b to Book of Order in 1996) have no further affect that action only unlocked..."

If this change is made to the Constitution of the PCUSA, it does not necessarily include unrepentant people of homosexual preference to participate in any ordained offices. It is presumed that the language change could open that door, but this is not a fact as was stated in the article. The Constitution has never allowed unrepentant people who have this sexual preference to participate in ordained offices. The fidelity and chastity amendment was first added because people said it needed to be specifically stated. So it was added and now they want it out. So now, if G. 6.0106b is amended, it only means that we are back to what we had originally. But nowhere in both parts of the Constitution of the PCUSA does it allow or approve that unrepentant people of homosexual sexual preference are allow to hold ordained offices in the PCUSA.
